
ALL INDIA SAINIK SCHOOLS ENTRANCE EXAMINATION FOR SESSION 2019-20

Dear Parent,

1. The final merit list of All India Sainik Schools Entrance Examination 2019-20 has been declared on **11 Mar 2019** for which written examination was held on **06 Jan 2019** and medical examination were conducted from **18 Feb 2019 to 27 Feb 2019**.
2. Your son/ward has been declared medically unfit by MH Bareilly due to the reason(s) as shown against him in the list.
3. Review medical board will be held at Command Hospital(CC) Lucknow in the last week of Mar 2019. Exact date will be displayed at school website by ___ Mar 2019.
4. In case you wish to appeal against the medical findings of MH Bareilly, you are requested to follow the instructions given below :-
 - (a) Submit the appeal (as per proforma attached) to this school alongwith copy of demand draft through email. The parent will have to pay Rs. 100/- through demand draft in the name of Principal Sainik School Ghorakhal, payable at SBI Bhowali (Code- 1352) towards fee for appeal against review medical board. Original appeal and DD will be collected by our school representative at Command Hospital.
 - (b) Get your son/ward examined by the Government Doctor for the medical problem mentioned in para 2 above and get a certificate that such problem does not exist.
 - (c) Alongwith the medical certificate mentioned in para 4 (b) above and statement of appeal as per the enclosed proforma, report to Medical Review Board at **Command Hospital Lucknow with your son at 0730 hrs** on the date which will be fixed by the school after your appeal.

5. The position of your son/ward has already been mentioned in selected/waiting list of final result. The wait listed candidates found medically fit by review medical board will be called for admission only if vacancy exists.
6. Candidates declared medically unfit by Military Hospital Bareilly, if do not appeal for Review Medical at **Command Hospital Lucknow** by 18 Mar 2019 will not be entitled to claim admission to the school thereafter.
7. The boy and parents should come prepared to stay in Lucknow for about 2-6 days. The parents have to make their own arrangements for their stay at Lucknow.
8. The decision of the Principal will be final and binding regarding admission to the school.
