1. Due to non receipt of Income certificate in time your ward may not be awarded scholarship.

2. It is intimated for your information that overwriting and incomplete income certificate will be rejected and your ward will be treated as **Full Fee Payee Student** for the session 2025-26. No further correspondence will be entertained in this regard.

3. The parents of **Defence serving personnel/Ex-serviceman** are required to forward the following certificate as per the details given below:-

(a) **Serving Defence Personnel:** Serving certificate duly signed by the OC unit giving full particulars of your service.

(b) **For Ex-serviceman:** A certificate from the District Soldier Board duly signed by Zila Sainik Kalyan Evam Punarvas Adhikari giving full particulars being ex-serviceman.

Note: Defence Scholarship will be awarded to eligible cadets within the limit provided based on merit-cum-means only as per guidelines of Sainik School Society, Ministry of Defence.

4. A student studying in Sainik School Ghorakhal will only be eligible for award of Uttarakhand State scholarship if he/she has secured 50% marks in each subject and 55% marks in aggregate in the annual examination 2024-25 and also subject to fulfillment of the income criteria of the parents as prescribed by the Government of Uttarakhand for award of scholarship to the cadet who belongs to Uttarakhand State.

5. **Please note that no further reminder will be sent for submission of income certificate and your ward will be treated as full fee payee cadet if the same is not received by 30 Apr 2025.**
